HAL revives jet trainer programme to help rookie IAF pilots

BENGALURU, FEBRUARY 21

AN INTERMEDIATE trainer jet programme — to help rookie Indian Air Force pilots transition smoothly from basic trainers to advanced jet trainers — which was shelved six years ago after multiple failures is being revived again, and a new improved IJT will fly as early as April 2019, a senior official from the PSU Hindustan Aeronautics Ltd (HAL) said.

"The IJT project has been revived. The spin problem, which had grounded the aircraft, has been addressed. There will be a flight in April of an IJT," Arup Chatterjee, HAL's Director (Engineering and R&D), said on Thursday on the sidelines of Aero India 2019.

The IJT, also known as Hindustan Jet Trainer 36, is an aircraft indigenously designed and developed by HAL to replace its own Kiran jet trainers — which were made from 1964 to 1989 and are now being retired from IAF service on account of their vintage.

"The IJT incorporates the simplicity necessary for ease of conversion from Basic Piston Trainer and the sophistication required for quick conversion to the complexities of an Advanced Jet Trainer," HAL said while embarking on building the aircraft more than 15 years ago.

The development of the IJT has, however, been marked by stops and starts. The aircraft stalled in 2007 at the Aero India when it was being unveiled before the public. Subsequently, the project made progress with the successful integration of a Russian engine AL-551 and the IAF placing an initial order for 73 aircraft which could go to 200 after the aircraft completes over 280 flights.

HAL not waiting for IAF, making products before orders: chairman

HAL HAS moved away from its strategy of depending entirely on IAF orders to build products and is now venturing into building products before orders are placed, chairman of the public sector aircraft manufacturer R Madhavan has said. As part of this new strategy, HAL has developed the HT-40, a basic trainer aircraft for IAF

pilots, and is now developing a Supersonic Omni Role Trainer Aircraft (SPORT) for training pilots who are on the cusp of being inducted into fighter squadrons. "Earlier we used to wait for the IAF to spell out its needs and then we would enter the picture. We now develop our products and then look for markets. SPORT is one project where we will launch and see if there are takers," the HAL chairman said at Aero India 2019. HAL is launching the fourth

generation SPORT to bridge a gap that is being felt in pilot training, Madhavan said. "We do feel bad when people talk poorly about us, but our morale is not down. Right from the union to middle management, workers are enthused to do better. When bad things are said, we take it in our stride," Madhavan said referring to criticism around its capability to manufacture Rafale aircraft which French maker Dassault Aviation expressed.

The account was classified as NPA as on 30.12.2017. Branch has recalled the advance vide it's letter no DB/ALK/ADV/083/2018 dated 18.05.2018 and also issued demand notice on 19.05.2018 under Section 13(2) of SARFAESI Act.
